It's a strong form of engagement and is designed to stimulate learners to want to find out more.
ENGAGE	Chapter Overview	1 per chapter	A brief introduction to the chapter and its LOs. LOs are hyperlinked to their corresponding A-heads.	2–3 minutes	This forms the final part of our scaffolded approach to leading the learner into the chapter. Once we've caught their interest with the video and got them thinking with the polling question, this tells them how all their questions are going to be answered. Providing certainty and clear pathways to learning are keys to retaining engagement.
